The defendant was sentenced to twenty years and two additional years. We attended a preliminary hearing in another case which was continued.

Chapter members attended 2 parole hearings and were pleased with the outcome of both. Even after serving 17 years, Don Corley (Homewood – pedophile) will stay another 5 years. Angelica, the defendant in the Sharma Ruth Johnson case, was denied for 4 years.

We also attended the signing of the Notification Bill and enjoyed spending the afternoon with Janette Grantham, Doris Hancock, Miriam Shehane, Emily Copeland, and Gloria Turner. We supported Doug Valeska at a hearing in Montgomery. Doug treated us all to lunch and we celebrated Miriam's birthday.

Chapter President, Carol Melton, had a bad scare on February 18. Her grandson, Jared, was in a wreck, rolled the truck and broke his neck. He had surgery and is recuperating.

Her father, Robert Hardin, worked out of the country and had left Savannah in the care of these two women, who are now charged with murder. Mr. Hardin at this time is in support of his wife and mother. Vocal will be in support of Etowah County District Attorney Jimmie Harp in this case, as he seeks justice for little Savannah.

Pat Jones is in our prayers - hang in there girl! Congratulations to Janette Grantham, our new chairman of the VOCAL State Board of Directors. We know Janette will do a great job -- no one fights harder for victims.

Our prayers go out to Miriam and her family over the loss of Jon. Parents should never have to bury a child, and certainly not two children. Miriam we love you!

Some Shoals VOCAL members attended the sentencing of Tommy Wallis after his conviction in the attempted murder of his wife. He shot her in the head, but thankfully she is doing well now. Thanks also to Judge Mike Jones for the life sentence. We have other murder trials in the next few months and we plan to support these families. Some chapter members have written letters of protest to the parole board and some will try to attend hearings soon.

Shannon Johnson entered a guilty plea to murder for his part in the murder of Keith Barnett in 2000. Shannon is to testify against his brother, Shawn, as part of the plea. The pre-trial hearing will be held on May 1 and the trial should begin on May 14. We will be there to support the Barnett family who has waited for so long for justice. We appreciate so much Lauderdale County District Attorney Chris Connolly, his Assistant District Attorney Angie Hamilton and each investigator for their diligence in solving this cold case and bringing the defendants to justice.



Shoals Chapter members assisted in organizing a candlelight vigil for Amanda Taylor. Amanda, age 32, was murdered October 17, 2011 in Colbert County. Her body was found burned, mutilated, and dumped in a wooded area. The vigil was held at the Colbert County Courthouse in Tuscumbia and was attended by 200 to 300 people. Friends and family described Amanda as a caring, loving person who was a good mother and faithful daughter. Amanda's father, Billy Leeth, was praised for his efforts in getting the word out that Amanda was missing, even though the case had not received much media attention. Ronald Eugene Weems, Matthew Richard Fox, and Laural Ann Pruett were arrested for the murder. Weems and Fox

were being held across the street from the courthouse, in the county jail, at the time of the vigil. Shoals members - Rebecca and Charles Condrey, Debra Gray, Johnnie and Denny Kimbrel – assisted with the vigil and will continue to support the Taylor family.

We continue to keep the Shehane family in our prayers for the recent loss of their son, Jon. We will keep Janette Grantham and her son, Duke, in our prayers, and as well as Carol Melton and her grandson. We are so glad to hear the good news for Pat Jones and will continue to pray for her.

The Southeast Alabama Chapter had a Christmas party at the VOCAL office in Dothan with delicious food prepared by Ann Kasler and other members. This event is always so special. We had five kids from one family whose father had been murdered. We put our "Memorial Christmas Tree" on the first floor of the Houston County Courthouse this year, the week after Thanksgiving. We wanted people to see it--and see it they did. Defense Attorney Joey Sheffield filed motions with the judges to continue his cases until after Christmas because he thought the tree would be prejudicial to the jury. The tree made national news.

Chapter members attended Troy King's father's funeral in December. That was a sad week. The Grantham family also found out that week that the 11th Circuit in Atlanta had denied the appeal to uphold the death sentence for Billy Joe Magwood for murdering Sheriff Neil Grantham. District Attorney Doug Valeska also attended the funeral for Mr. Bobby King. Sheriff Grantham is buried in the same cemetery as Mr. King. We visited his grave also

We attended a parole hearing in January with Ann and Jack Murphy who were victims of a home invasion in 2001. There were 5 co-defendants. One was a youthful offender. The other 4 had 99-year-sentences and were eligible for parole; they were denied parole for 5 years. We also attended a capital murder trial in Dothan which had been reversed for resentencing for killing 3 people and shooting another.

Our candlelight vigil will be held on Sunday, April 22, at 3:00 p.m. at the First Presbyterian Church in Dothan. Please pray for Janette Grantham and her family. One of her sons was attacked last week in Tuscaloosa and broke both jaw bones in 2 places. He had surgery and his jaws are wired together. He had severe complications afterwards but is better now. Another one of her sons is being deployed to Afghanistan. Carol Melton's grandson was in a wreck recently and broke a bone in his neck and had surgery. Our prayers are with Miriam and Edward Shehane as their son, Jon, died January 31 in Ohio from cancer.

BIRMINGHAM JUDGE DISMISSES CHARGES IN MURDER TRIAL

In February, Gabe Watson went on trial for murder in Jefferson County. He had been charged in connection with the drowning death of his newlywed wife in Australia while scuba-diving in 2003. Over the past couple of years, VOCAL members had become closely acquainted with the family of Tina Thomas, the victim. We were in court with them each day during jury selection and the trial. Although the death occurred outside of the U.S., a Jefferson County grand jury indicted Watson under the premise that he planned the crime here in Alabama and planned to collect on his wife's life insurance.

The Attorney General's office handled the prosecution and the case received enormous media attention. After almost two weeks of testimony, the state rested. Many of us have become familiar with the common strategy used by defense lawyers to make a motion for the judge to dismiss charges and acquit either after the state has rested and/or before the jury begins deliberations.

That same strategy was expected in the Watson murder trial; however, many were stunned when Judge Tommy Nail GRANTED the defense's "motion to dismiss." Watson was free to go and cannot be prosecuted for this crime again (because of double-jeopardy protections). As you might imagine, the victim's family is devastated. For eight years, they had yearned for a jury to hear the evidence in open court and let a jury determine the guilt/innocence of Gabe Watson, but that will never happen after the judge's actions in February. They had felt short-changed in Australia because of the light sentence Watson received after pleading guilty to manslaughter there, and now they feel betrayed in Alabama.

After Judge Nail's ruling, lead prosecutor Don Valeska told the media that he had never seen this occur during his 40-year career. An amazing effort was put forth by Mr. Valeska and his team, including Andrew Arrington, Tina Hammonds Coker, Jon Hensley, Gene Sisson and so many others. Former Attorney General Troy King and current Attorney General Luther Strange had allocated resources to allow this case to see the inside of a courtroom; it's unfortunate a jury never had the opportunity to deliberate and render a verdict.

LEGISLATIVE UPDATE

- SB 22 Sponsor Senator Scofield. To make it a capital offense for a defendant to murder a person in violation of a protection order issued on behalf of the victim against the defendant. Status: In Judiciary Committee.
- SB 63 Sponsor Senator Orr. Relating to DOC prison industries, inmate training; to authorize the department to contract with private industry for on-site work programs (companion bills HB 30 & 36). Status: In State Government Committee.
- SB 67 Sponsor Senator Sanders. To provide an exemption from the death penalty for persons who were less than 18 at the time of commission of the capital offense. Status: In Judiciary Committee.
- SB 68 Sponsor Senator Sanders. To provide a death penalty moratorium (companion bill HB 116). Status: In Judiciary Committee.
- SB 69 Sponsor Senator Sanders. To prohibit a court from overriding a jury verdict in a capital case. Status: In Judiciary Committee.
- SB 101 Sponsor Senator Allen. Relating to DOC to provide, subject to exceptions, that it should be unlawful for an inmate to possess a cell phone, wireless communication device, or computer. Status: In Judiciary Committee.
- SB 161 Sponsor Senator Brooks. Enhance penalties for subsequent conviction of first degree human trafficking and second degree trafficking; provide for the deposit of fines in the ACVCC Fund; sex offenders required to disclose internet service providers. Status: Passed the Senate, now in House Judiciary.
- SB 182 Sponsors Senators Fielding, Orr, Bedford, Irons, and Beasley. Relating to DOC; to require correctional officers to carry a firearm when supervising inmates on work squads outside of a secure facility. Status: In Judiciary Committee.
- SB 392 Sponsor Senator Sanders. To remove death as a punishment for a capital offense. Status: In Judiciary Committee.

- HB 30 & 36 Sponsor Representative McClendon. Relating to DOC prison industries, inmate training; to authorize the department to contract with private industry for on-site work programs (companion bill SB 63). Status: In State Government Committee.
- HB 73 Sponsor Representative DeMarco. Provide an income tax refund check-off for a contribution to VOCAL. Status: Passed House and out of Judiciary Committee.
- HB 77 Sponsor Representative England. To authorize a person to petition a court for expungement in certain instances. Status: In Judiciary Committee.
- HB 116 Sponsor Representative Coleman. To provide a death penalty moratorium (companion bill SB 68). Status: In Judiciary Committee.
- HB 137 Sponsor Representative McCutcheon. Increase the age of consent for sexual acts to 18. Status: In Judiciary Committee.
- HB 175 Sponsor Representative Payne. Relating to a person charged with crimes committed in their minority who are eligible to be considered for youthful offender status; to provide notice to the victim prior to a hearing. Status: Passed the house. Out of Senate Judiciary Committee.
- HB 202 Sponsor Representative England. Provide for the nonpartisan election of the state attorney general, Supreme Court Justices, judges, and appellate judges. Status: In committee.
- HB 561 Sponsor Representative Barton. To make an appropriation of \$196,978 from the general fund to the Alabama Coalition Against Domestic Violence. Status: In committee.


