A NOTE FROM STATE DIRECTOR, JANETTE GRANTHAM

There has been a little excitement here at VOCAL Headquarters. A professor from Troy University is writing a textbook about the Criminal Judicial System, and it will include a chapter about victims and victim's rights. VOCAL has been contacted as they want to include Miriam and her fight for victims' rights. VOCAL will also be a topic covered in this chapter.

Just after this news, Miriam was contacted by producers at ID Network. They want to tape a segment about Quenette and Miriam to air on the program, "On The Case With Paula Zahn." Miriam; her daughter, Sonya; former DA David Barber; and Quenette's boyfriend, Ramsey Lane, will fly to New York next week to tape the segment. As you can imagine, this will be a difficult time for the Shehane family. Please keep them in your prayers as they relive the trauma of the crime.

Earlier this week a group of victims met with Department of Corrections (DOC) and received some training on work release, community work centers, and the difference between the two. We came away with a better understanding of the operations of DOC. VOCAL thanks Commissioner Kim Thomas, Deputy Commissioner Jeff Williams and their staff for taking the time to meet with us and providing us with information which we can pass along to victims.

Victims meet next week with the Council of State Government (CSG). This will be our final meeting before CSG provides their recommendations to the Prison Task Force. VOCAL is dedicated to ensure victims' rights are not violated. The Prison Task Force will meet with CSG later this month for their report. Many of us already have a feel for some of the recommendations which will be made, but wonder where we will get the funding.

COUNSELOR'S CORNER

Grief is normal.....there is no certain way to mourn the loss of a loved one. Grief not only comes when you lose a loved one, but it could come when dealing with terminal illness, the loss of a relationship, children dealing with a divorce, etc. In our lives we grieve differently depending upon the individual and the situation. It's important to know that grieving is OKAY. According to Kubler-Ross model of grief, there are five primary responses to loss.

The first stage is "Denial" meaning the individual refuses to accept the fact that a loss has occurred or deny the situation even happened. The second stage is "Anger" meaning once they have realized that a loss has occurred they may become angry at themselves or others. The third stage is "Bargaining" where an individual may try to change or delay a loss; for example, convincing a partner to come back after a breakup. The fourth stage is "Depression" meaning they have recognized the loss and begin to isolate themselves and spend more time crying and grieving. The fifth stage is "Acceptance" meaning the individual will come to accept the loss.

There is no set order as to when an individual will go through these stages and they may return to previous stages over time; the important factor is that you grieve. Also one must recognize when it's time to seek help. There is nothing wrong with asking for help in the time of need to get you to the acceptance stage of grief. This stage does not mean that you will forget your loved one, but it will help to focus on the happier times. VOCAL hosts a Candlelight Vigil every April to remember loved ones. This vigil will be held on April 24, 2015 at 6 p.m. in Montgomery to honor and reflect on the lives of those loved ones taken away by homicide crimes. CHAPTER NEWS

CENTRAL ALABAMA CHAPTER

Chapter President Mitzie Wheat attended training on November 19 entitled "A Victim's Plea" which was sponsored by the Pelham Police Department. This training focused on avoiding the many mistakes that were made in the case of Denise Lee. In 2008, Denise Amber Lee was abducted by Michael King in Florida. In the hours that ensued, Denise fought for her life. In her battle, she was able to use the captor's cell phone to call 9-1-1, an act she thought would save her life. She was not the only one to call 9-1-1 that day regarding this crime; there were at least four others. Despite the fact that as many as four patrol cars were within a mile of the car in which Denise was fighting for her life, due to inefficiencies in the call center, none were dispatched. Two days later, Denise's body was found. It is in memory of Denise and the tragedy that could have been prevented that the Denise Amber Lee Foundation was formed. The goal is to implement changes to a 9-1-1 system that failed her that day.

Chapter members Ronnie and Vonciel Dodson, Cheryl Robinson, and Mitzie Wheat attended a meeting at the Department of Corrections office in Montgomery on January 12. We learned much about the classification and placement of inmates, the computation and application of good time, and the operations of DOC.

Chapter members will be working with SafeHouse and other victim service organizations to plan our Candlelight Vigil to commemorate National Crime Victims' Rights Week.

We appreciate the memorial donation made to the chapter by Ronnie and Vonciel Dodson for Desta Dodson-Byrd.

Our next meeting will be held on Saturday, February 14, 2015 at 2 p.m. at the Owens House in Columbiana.

GULF COAST CHAPTER

Rochelle says this is a secure site and your email address will not be sold/traded/etc. After you register, it will allow you to add additional email addresses for notification so you do not miss a notification. We all need to be proactive and do our little part to stay informed. Don't forget to sign up.

Member Luci Murphy gave us an update on the status of the case against the killer of her granddaughter Teela. They are awaiting the docket to be set and we all pray that the case will be on the February docket. As Luci detailed, it will be three years on April 19th and as many of us know, a very painful and out of control three years. Fred King, as well as Tammy Toler, Kayla Beck, Tara Ratz and Amy with the DA's office gave Luci some thoughts on house arrest and ankle monitoring and how it typically works and some guidelines.

them insight of the plight of victims. These are all "front line folks" and we pray for their strength and compassion as they see every day the worst of the worst.

They also discussed the conviction and sentencing pending on Wendy Holland, who is believed to be involved in a long-running family sex ring. These terrible crimes were brought to light through the hard work on investigators on both sides of our Bay in Baldwin and Mobile Counties, and this twisted family reign over these children will now come to an end. Many more cases to come in both counties and God Speed to all involved.

The membership is planning on a bowling night in February and chapter President Tracey Goens will be contacting the local bowling alley and get the membership more details on that.

Crime Victims' Rights Week is April 19-25th and it looks like we will hold our Candlelight Vigil on the 20th. Stay tuned for more details and information. We will be asking for volunteers to be on the Vigil Committee, so if you are interested please contact Tracey Goens at 251-533-6832.

Finally, we have some members whose cases are still pending and ask that you continue to join us in lifting them up in prayer.

JEFFERSON COUNTY CHAPTER

Our chapter has been assisting families of victims by providing meals during trials. Trials have been held for two of the three offenders charged with killing five men in West Birmingham. The men were killed on January 19, 2012 at a house at 3113 Avenue South, which is in the Ensley Highlands neighborhood (Charles "C.J." Render, 21; Ronnie Render, 42; Demetrius Sanford, 19; Jeffrey Davis Jr., 23; and Jonathan Sanchez, 23). Artavius Underwood, who was charged with capital murder in the deaths, pleaded guilty and is serving a life sentence. He became the first person sentenced for capital murder to ever be eligible for parole, due to his age and new sentencing guidelines set out by the Alabama Supreme Court in response to a 2012 U.S. Supreme Court ruling. Rashad Stoves was found guilty of five counts of felony murder and one count of reckless manslaughter and faces a possibility of 20 years to life on each of the felony murder counts and two to 20 years on the reckless manslaughter verdict. He will be sentenced in about six weeks.

The death penalty is not possible because Stoves was under the age of 18 when the slayings occurred. Reginald Mims, the last of the three offenders, will be tried in February.

The family of a Hanceville man, who along with his wife and their 10-month-old daughter were killed in 2012 when two men fleeing police crashed into their car, doesn't feel like justice was served with the sentences handed out in the case. Ryan Culwell, Amber Nicole Verus, and 10-month-old Rogue Marie Culwell, were killed in an October 2, 2012 crash with an SUV on Birmingham Road in western Jefferson County. When the crash occurred the two men in the SUV had been fleeing police after they robbed and pistol-whipped a Walker County man. Dominique Rashad Smith, the driver of the SUV that struck the Culwell family's car, pleaded guilty to three counts of felony murder under a deal with prosecutors and was sentenced to 20 years in prison. Under the deal, Smith was to testify against Jeffery Bernard Howe, the passenger in the SUV. But Howe entered a guilty plea - without a deal - just before his September trial was to have begun. Howe was sentenced by Jefferson County Circuit Judge Bill Cole to 19 years in prison - one year less than Smith.

We assisted a daughter whose mother was set on fire by an ex-boyfriend. Deborah Diane Prater (49) was doused with gasoline and set on fire by her ex-boyfriend, 48-year-old Michael Kennedy. Investigators learned she had been dating Kennedy for the past three years and had recently ended the relationship. Kennedy went to Prater's Edgewater home, and after an argument, he poured gasoline and then threw a lit cigarette on her. Prater sustained burns over 35 percent of her body, the most serious to her face, chest and arms. Initially she was in serious condition, but her condition deteriorated and she died as a result of the attack. Court records show that her daughter witnessed the attack. Kennedy had driven Prater's vehicle from the scene. When Kennedy was arrested, the vehicle was towed so that evidence technicians could process it to obtain evidence. Initially the wrecker service that towed the vehicle was asking \$1,500 to release the vehicle, but we were able to assist in having that amount reduced to \$250.

We also helped Mrs. Gonzales with funds for travel expenses. Her daughter, Crystal, was stabbed to death by her boyfriend. Mrs. Gonzales came to Birmingham on a wing and a prayer to bring her daughter back home. She took her daughter's body back to Texas in the back of her SUV.

JEFFERSON COUNTY CHAPTER *continued*

Jefferson County VOCAL members were among those who gathered for a rally to honor police officers who served and are serving in a positive way in Birmingham. The rally was held outside the Mel Bailey Criminal Justice Center at the statue of the Roman centurion above an honor roll of slain officers, whose deaths in Jefferson County date back to 1889. The event was designed to show the public that law enforcement is not the enemy and to show officers that the community supports them. Officers stated that they cannot do their job without community support. Organizers wanted to make a statement that those lives also mattered, and are not forgotten.

RIVER REGION CHAPTER

This winter has been a difficult season for our chapter as we mourn the loss of our longtime member and friend Gayle Frost. In 1989, Gayle was attacked when a man broke into her Montgomery home and waited for her to return. He beat her badly and left her for dead. After many painful days in the hospital and numerous surgeries, Gayle joined VOCAL within a few weeks and was always a dedicated member. She served many years as chapter treasurer and also in the same role for VOCAL's State Board. Chapter President Darlene Hutchinson Biehl joined VOCAL in 1989, the same year as Gayle, and cherished their friendship: "Gayle was the most diligent treasurer any organization could ever want. Every penny was always documented, and she was a dedicated member who spoke frequently to friends (and strangers) about the organization and the dilemmas victims often face. She truly personified what it meant to be a survivor! We have lost one of our unsung heroes, but we'll always remember Gayle fondly and her jovial personality." Chapter members will continue to fight the parole of Gayle's attacker, alongside her children Tony and Tonya.

Our members congratulate newly elected Montgomery Sheriff Derrick Cunningham, who has been a great supporter to VOCAL over the years, and we thank retiring Sheriff D.T. Marshall for his service to the community and for also being a faithful VOCAL supporter. Autauga County has a new leadership too; we look forward to getting to know Sheriff Joe Sedinger and we wish retiring Sheriff Herbie Johnson well.

Our members continue to monitor what's happening with the Victim Notification System (also known as AlabamaCAN) which is still in development, even though the program and website were officially launched in October. We should have more to report on that project in the spring.

And we're eagerly watching what the Prison Reform Task Force will propose to the Legislature, which may have a tremendous impact on the entire criminal justice system. The Legislature convenes on March 3 and is expected to address prison overcrowding and other reforms to the justice system. Because of our close proximity to the Capitol, our members are often checking in on measures that may affect victims, and insure the perspectives of victims are always considered.

Many of us will also be at parole hearings on February 11 for the three men involved in an awful two-county shooting spree that occurred December 1991 and changed the lives of many people forever. Julia Lindsey was murdered that night, and the criminals also attempted to kill at least three others. Please assist us in protesting the paroles of Benjamin Oryang #168079, McArthur Harris #167854 and Tyrone Gibson #167847 (by attending the hearings at 8 a.m. on February 11, and/or sending a letter to the Board of Pardons and Paroles; see address on back page of newsletter).

Our chapter meetings continue to be a good cross-section of victims who have suffered awful tragedies – some just recently, others two decades ago – each supporting one another, offering encouragement and being effective advocates for others. And providing tangible services to crime victims is very important to our chapter members.

SHOALS CHAPTER

Shoals Chapter members, along with Deborah Bates' brother Bennie Ragland and VSO Deanna Tidwell, protested the parole of David Whitson. Whitson is serving a 30-year sentence for the 1988 murder of Deborah Bates; parole was denied and Whitson will serve his entire sentence. Bennie Ragland has attended every prior parole hearing and was overwhelmed with the prospect of Whitson being released after all the years of protesting paroles to ensure the sentence was carried out. Members of the chapter were also present for the sentencing of Shannon Brewer, he pleaded guilty to the murder of Mark Dishon in 2012 and was sentenced to 25 years.

Mary Anne Rippey along with VSO Deanna Tidwell attended the third Prison Reform Task Force meeting, we were able to sit in and listen to problems our prison system has and the work that is going into reforming the system to prevent the federal government from coming in and forcing changes. Pardons and Parole, criminal charges, and sentencing were also discussed. We will keep a close watch on meetings to ensure victims are always represented.


